CIRCULAR TO PARENTS – CLASS XII (CBSE) 2025–2026

CBSE Assessment Scheme & Submission of Answer Scripts (Special Circumstances – West Asia)

Dear Parents,
Greetings from Indian School Al Wadi Al Kabir.

In continuation of our earlier communication and in accordance with CBSE Notification No. CBSE/CE/SPPS/2026/2 dated 27.03.2026, we would like to inform you about the assessment criteria and procedures for the declaration of Class XII results under the special circumstances prevailing in the West Asian region.

Background: Due to the current geopolitical situation, CBSE has cancelled examinations scheduled from **16.03.2026 to 10.04.2026**. Accordingly, an **Alternative Assessment Scheme** has been introduced to ensure fair and unbiased evaluation of students.

Assessment Criteria: The Class XII results will be prepared based on the following:

- Performance in Board Examinations conducted up to **28.02.2026**
- Internal Assessments and Practical Examinations already submitted to CBSE
- School-based assessments, including:
Unit Test/ Assessment 1/ Pre-Board 1 (Common Pre-Board Examination)/ Pre-Board 2

For subjects where Board examinations were not conducted, marks will be awarded as per CBSE-prescribed methodology, which includes:

- Pre-Board performance for skill-based subjects: {Physical Activity Trainer (845) and Marketing (812)}
- Best performance among internal examinations for all remaining subjects:
{Psychology (037), Mathematics (041), English Core (301), Economics (030), Informatics Practices (065), Computer Science(083), Biology (044), Business Studies (054), and Sociology (039)}

Important Note

- CBSE may call for **physical records and answer scripts** to verify the accuracy of marks submitted by the school.
- Schools are required to maintain these records for a **minimum period of one year** for verification purposes.

Action Required: Submission of Answer Scripts

Parents are requested to submit their ward's answer scripts of Unit Test/ Assessment 1/ Pre-Board 1 (Common Pre-Board Examination)/ Pre-Board 2 (if available) for the following examinations: Psychology (037), Mathematics (041), English Core (301), Economics (030), Physical Activity Trainer (845), Marketing (812), Informatics Practices (065), Computer Science (083), Biology (044), Business Studies (054), and Sociology (039).

To facilitate efficient verification, kindly arrange the answer scripts assessment-wise.

- Each set should be securely compiled, and a cover sheet must be attached clearly on top mentioning the student's name and CBSE Roll No.

Submission Schedule:

- **From:** 31st March 2026 to 2nd April 2026
- **Time:** 8:00 AM to 12:00 Noon
- **Submission to:** Respective Class Teachers

Kindly ensure that the answer scripts are **properly bundled subject-wise / exam-wise** for smooth verification.

Special Advisory to Parents

We understand that, due to the prevailing situation, some students may not have their answer scripts. Parents are requested **not to panic**.

In such cases:

- Submit a **Declaration Form** (format shared by the school) stating the inability to provide the answer scripts.
- Attach a copy of the **report card issued by the school**, duly signed by the parent, confirming the marks obtained by the student.

The school will proceed as per CBSE guidelines and ensure that no student is disadvantaged.
